

## **Guidelines for admission to ME/MTech/MPharm (PG Program) on sponsored category**

Following criteria shall be adopted for admission to ME/MTech/MPharm on sponsored category

- As per the earlier minutes, PG programs of Government and SFI institutes with intake 18 or more, five seats to be retained as sponsored seats.
- Course wise Seat matrix for sponsored category shall be declared separately
- Applications of sponsored candidates shall be classified in following three categories (Separate merit list should be prepared)
  1. Government Faculties-Degree and Diploma Institutions.
  2. SFI Faculties- Degree and Diploma Institutions.
  3. Industries sponsored.
- Admission counseling for sponsored category shall be done in the sequence of (1) Government Faculties (2) SFI Faculties (3) Industries sponsored categories.

### **Criteria of selection of Sponsored Candidates:**

#### **I. Government faculties:**

- Valid GATE score holder or minimum 25% score in entrance test exam.
- Admission shall be exclusively on the bases of GPSC seniority within the discipline.
- In case of excess faculties wanting deputation in a particular discipline, pro rata based number of faculties shall be fixed considering total applicants in Government institutions.
- PG Programs of Government Institute shall be given preference in admission.
- Length of service shall be as per prevailing Government orders
- Recommendation of head of institute with necessary bond and under taking shall be submitted at the date of counseling
- In case of undertaking of alternative arrangement for teaching workload is not possible due to shortage of

faculties, equal workload arrangement shall be done at institute level among the departments. Faculty may also be sponsored if he/she is willing to take workload at the Government institute where admission is availed.

## **II. Self Finance Inst Faculties**

- Admission shall be given based on merit as per following sequence:
  1. Valid GATE Score
  2. Entrance Test Score
- Minimum length of service 02 years
- Selection of faculties on regular basis with due evidence.
- In case of excess faculties wanting deputation in a particular discipline, pro rata based number of faculties shall be fixed considering total applicants in Government institutions.
- Sponsored ship letter for granting full time deputation shall be submitted at the time of admission

## **III. Industries Sponsored:**

- Admission shall be given based on merit as per following sequence:
  1. Valid GATE Score
  2. Entrance Test Score
- Any reputed legally registered industries/firm/society/company etc. involved in technical activities shall be eligible to sponsored the candidate (Evidence to be submitted)
- Technical background of sponsored industries/firm/society/company etc. shall be verified and decision of Member Secretary shall be final in this matter.
- Minimum two years of experience with the industries/firm/society/company etc.(Proof of form-16 shall be submitted)
- Sponsored ship letter for granting full time deputation shall be submitted at the time of admission
