Accordingly candidates who have been allotted seats in round 1 are hereby informed to report to allotted institute latest by 6/9/2016. If any candidate who has been allotted seat in First round and has not yet confirmed the said allotment, such candidates are given one more opportunity to confirm the same at their allotted college/institute level latest by 06/09/2016, so as to become eligible for reporting and further study at allotted institute. The vacant seats after round 1 are displayed on ACPC website. The vacant seats in SFI shall be filled strictly as per provision of rule 20 of prevailing notification, accordingly candidates who are willing to participate in vacant seats and are already in the merit list of the Admission Committee shall have to give on-line consent on www.gujacpcadm.nic.in from their login ID. as per schedule given above to participate for the vacant seats round. Whereas the eligible candidates who have not registered earlier or if they have registered earlier but not appeared in Common Entrance Test of current year, conducted by the Admission Committee shall have to register online on www.gujacpcadm.nic.in as per the above mentioned schedule to participate in vacant seats for SFI institutes. A candidate who has given his consent or who is newly registered shall only be allowed to participate in admission procedure for the vacant seats.
