- 3) TO GET THE BENEFIT OF TFW SCHEME, THE CANDIDATE MUST SUBMIT THE INCOME CERTIFICATE ISSUED AFTER 31ST MARCH 2017 FROM EITHER 'MAMLATDAR' OR 'TALUKA DEVELOPMENT OFFICER' ON THE SPOT AT THE TIME OF COUNSELLING (1ST AUGUST 2017).
