Admission in Vacant Seats after two online rounds of M.E./M.Tech./M. Pharm Courses, Academic Year 2018-2019

For **vacant seats in Govt./Grant-In-Aid, University managed Government (Un-aided) institutes** the committee is planning to conduct an online round for these vacant seats. The detail proposed schedule for the same is as follows. The vacant seats details are available on committee's website.

However, the **vacant seats in Self Finance Institutes (SFI)** shall be filled as per provisions of rule 20 of prevailing notification, accordingly candidates who are willing to participate in vacant seats and are already in the merit list of the Admission Committee shall have to take print out of their Registration form and submit to institute of their choice as per schedule given below to participate for the vacant seats round. **Whereas the eligible candidates who have not registered earlier or if they have registered earlier but not appeared in Common Entrance Test of current year, conducted by the Admission Committee** shall have to register online on www.gujacpcadm.nic.in after purchasing PIN Cover from designated branches of Kotak Mahindra Bank by paying a fee of Rs. 500/- (Non-Refundable) (List of designated branches is available on committee's website) as per the below mentioned schedule to participate in vacant seats for SFI institutes.

All eligible candidates who are already registered or newly registered shall have to take print of the registration form and approach self-finance institute of his choice for admission on vacant seats as per schedule mentioned in following table. There is no need to report at help center for document verification.

A candidate who has submitted copy of his registration form along with copies requisite documents as above shall only be allowed to participate in admission procedure for the vacant seats. The concerned self-finance institute shall process the filling up of vacant seats among such eligible candidates who have submitted the registration form as per provisions of Rule 20 of prevailing notification of Government of Gujarat for Admission to ME / MPharm courses.

The detail guidelines for filling vacant seats in SFI institutes at institute level are available on committee's website. The detailed schedule for the vacant seats in SFI is as below.

In case of admission to SFI in vacant seats, the process for refund of fee for seat already allotted by this committee shall be as per rule 19 of prevailing notification of Government of Gujarat for admission to ME/MTech/MPharm courses.
