GUJARAT PROFESSIONAL TECHNICAL EDUCATIONAL COLLEGES OR INSTITUTIONS
(REGULATION OF ADMISSION AND FIXATION OF FEES) ACT, 2007.

No : GH-SH-7/2008/PVS/102003/639/S:- In exercise of the powers conferred by the sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules to provide for the constitution of the admission Committee to regulate the admissions of students to the professional courses, namely :-

1. **Short Title and Commencement** .- (1) These rules may be called the Admission Committee for Professional Courses (Constitution and Functions) Rules, 2008.
- (2) They shall come into force on and from the 5th May, 2008.
2. **Definitions** .- (1) In these rules, unless the context otherwise requires,-
 - (a) "Act" means the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008);
 - (b) "Admission" means admission of students in the degree or diploma in the professional courses;
 - (c) "Committee" means Admission Committee constituted under section 4 of the Act.
- (2) The words and expressions used in these rules but not defined shall have the same meanings as assigned to them in the Act.

3. **Constitution of Committee.-** (1) For the purpose of admission of students to the professional courses, there shall be constituted a Committee called "the Admission Committee for Professional Courses".

(2) The Committee shall consist of the following members, namely :-

- (a) The Director of Technical Education, Chairman, *Ex-officio*;
- (b) The Joint Director of Technical Education, Member, *Ex-officio*;
- (c) The Principal, L. M. College of Pharmacy, Ahmedabad, Member, *Ex-officio*;
- (d) The Principal, L. D. College of Engineering, Ahmedabad, Member – Secretary, *Ex-officio*;

4. **Functions of Committee.-** (1) The Committee shall supervise, monitor and control the process of admission of the students seeking admission in the following Professional Courses, namely :-

- (i) Bachelor of Engineering and Technology;
- (ii) Bachelor of Pharmacy and Diploma in Pharmacy;
- (iii) Bachelor of Architecture,
- (iv) Bachelor of Hotel and Tourism Management,
- (v) Bachelor of Engineering and Technology after Diploma in Engineering,
- (vi) Bachelor of Pharmacy after Diploma in Pharmacy.

(2) The Committee shall cause to prepare the merit list in accordance with the provisions of the Act and the rules made thereunder.

(3) The Committee shall cause to allocate the Government seats and the Management seats in accordance with the provisions of the Act and the rules made thereunder.

(4) The Committee shall ensure that admissions in the Government seats and the Management seats are made as per the merit list prepared and that no student is admitted against the Management seats unless his name appears in the merit list.

(5) The Committee shall perform such other functions as may be assigned to it by the Government.

5. **Powers of Committee.-** In discharge of its functions under the provisions of the Act and the rules made thereunder, the Committee shall exercise such powers as are conferred upon it under the provisions of the Act.
